Minutes of Previous Meeting September 5, 2024 On a motion by Trustee Mohr, seconded by Trustee Fonzone, the minutes for the September 5, 2024, LCCC Board of Trustees meeting were approved.

Treasurer's Report

David Hein, Treasurer, provided the Treasurer's Report as listed below:

Total revenues are \$14.9 million or 31% of the budget compared to 25% last year; Total expenditures are \$7.4 million, or 16% of the budget compared to 17% last year.

College administration continues to review and restructure open positions as needed.

Dr. Bieber reported she attended the first meeting of the State Board of Higher Education. Under Legislative Update, the power point and notes are posted for review. Dr. Kate Shaw will be visiting the campus tomorrow. The timeline is aggressive and many meetings are expected to be held to keep things moving and on track. Key dates are: April 2025 – establish a state related funding formula council, which will develop funding recommendations; May 2025 – recommend higher education authority to transfer to State Board of Higher Education; September 2025 – adopt a strategic plan for higher education. There are eight meetings planned across the state to get stakeholders input for the Strategic Plan. Four committees have been formed to develop the plan, By-Laws, Transition of Authority, Data Systems and Performance Based Funding.

Dr. Haney reviewed the Enrollment Dashboard for Fall. Total headcount is down 3% and total credit hours are down 6.5% for same point in time last year. Dual Enrollment is up overall and Brandon Kwiatek will be presenting his report tonight.

President's Report

Personnel, Curriculum and Government Relations Committee Presentation: High School Connections 2024 Dr. Kistler welcomed Brandon Kwiatek to continue with his presentation, High School Connections 2024.

Mr. Kwiatek began by explaining the difference between Dual Enrollment and Early College. Dual Enrollments students are enrolled in on or more LCCC classes at their high school, online/remote or on campus. Early College is a program for 11th and 12th grade students who enroll full time at LCCC for two years earning their General Studies A.A. degree while simultaneously earning their high school diploma.

He provided a comprehensive outline of each program, highlighting the following; for the 2023-2024 school year, 2,362 DE students were enrolled in 270 courses; dual enrollment classes are offered in 21 different high schools in 16 school districts; enrollment trends continue to increase – fall 23 to fall 24 showed an 8.2% increase in headcount and fall 23 to fall 24 showed a 10.1% increase in credit hours. Improved communication and information include; an updated website page, 'self-service' online drop/add forms and added high school information sessions, Application Days and Registration Days. This is all designed to get students to begin thinking like a college student and prepare them for future college decisions. New opportunities include; a partnership with Commonwealth Charter Academy, online ASL course at Emmaus High School and seven new dual enrollment classes approved at Emmaus High School.

Early College highlights include; 222 students have graduated with Associates Degree's and transferred to 36 different colleges and universities since the program's inception in 2021. There are currently 160 students enrolled in EC with expected graduation dates of August 2025, 2026 and 2027. Academic resources available include, Advising, Learning Support & Tutors, and Success Coaches.

Questions raised:

Do you see the program plateauing? Not dual enrollment but possibly with EC as there are only so many high achieving students that have interest in the program.

Trustee Mohr asked how he can assist in bringing dual enrollment to Southern Lehigh? (currently Southern Lehigh does not participate). Brandon suggested talking with the Principal and Superintendent. Brandon is willing to assist if needed.

Are high school teachers allowed to teach DE and EC classes? Yes, with a Master's Degree.

Chair DeFrank thanked Mr. Kwiatek for the extensive review of the programs.

Trustee Kistler referenced the committee meeting minutes of September 16 and noted the success of the Tony Boyle Golf Classic where she presented the Collegiate Award of Distinction to the grandson of the late Bruce Rothrock. The Trustee Self Evaluation summary report will be sent October 24.

PACCC Legislative/ Governmental Affairs Update Trustee Thompson reported Dr. Bieber has been appointed Chair of the Transition Committee, with Board approval. Trustee Thompson referenced the PA State Board of Higher Education Overview and Authority document noting the data was rather depressing and that the Governor has the ambition and fore-site to make changes. The document paints the picture with facts.

Finance and Facilities
Committee

Trustee Mohr reviewed this committee's minutes for September 16, 2024. The committee reviewed the Cash Flow and Revenue and Expenditures reports along with the Enrollment report. The Enrollment Management Plan was reviewed. The Colleges' Investment Policy Statement was reviewed. And there was discussion and review of the Critical Incident Team Protocols.

Since the meeting, a change order was sent for the Donley Center façade. The change order comes from the façade needing further adhesive repairs, the total amount not to exceed is \$41,800.00. VP Nester explained there is an additional 10% add on fee that is part of their administrative costs associated with any change order.

LCCC Foundation

Dr. Kistler reports the Foundation is hosting Rocky Bleier, motivational speaker and former Steelers football player, at the Glasbern Inn on Monday, November 4. Proceeds support scholarships for veterans. Tickets are available on the Foundation website. She also reports the Institutional Advancement Grant Agreement (IAG) is a legal agreement between the college and the Foundation that states the college will provide the Foundation with an annual operating budget. Currently the Foundation reimburses the college for 70% of all operating expenses. At the September Foundation Board of Directors meeting they voted to increase the reimbursement to 80% in 24-25 and 100% after that. Also, the Foundation annual appeal will begin soon with five giving priorities; Cougar Fund, Strategic College Initiatives, Student Activities & Events, Student Health & Wellness, and Scholarships. Gifts of all sizes are appreciated. December 31, 2024 is the deadline for the appeal.

Dual Enrollment

Dual Enrollment students are enrolled in one or more LCCC classes at their high school, online/remote, or on campus.

2023-2024: 2,362 Dual Enrollment students were enrolled in 270 courses (55 at high schools, 215 at LCCC).

Dual enrollment courses are offered by LCCC in 21 different high schools in 16 school districts, charter schools, private schools and career and technical institutes across Lehigh, Carbon and Schuylkill counties.

Early College

Early College is a program for 11th and 12th grade students who enroll full-time at LCCC for two years, earning their General Studies A.A. degree while simultaneously earning their high school diploma.

Since the first graduating class of 2021, a total of 222 Early College students have graduated with the Associate's Degree and transferred to 36 different colleges and universities.

In Fall 2024, LCCC began its sixth year of offering Early College for high school students.
