Attendance - How to take Attendance in your Canvas Course

You can use the Canvas Attendance feature as a tool to help you keep track of attendance to then input this into BannerWeb. To read about the instructions of how to mark attendance view the directions below. 1. Click on the Attendance button from the course navigation panel inside your course. This will load your current class roster in the list view.
2. To quickly mark everyone in the class as present click on the Mark All Present button.
3. To quickly mark individual student's attendance you can keep clicking on the button to toggle between the attendance markings: present, absent, late, and unmarked.
4. You can also see these options by clicking on the more button on the individual student's row and then clicking the option you wish to mark them.
5. You can also navigate to other dates by toggling through the date options in the left hand corner or clicking on the calender to open up a calendar for you to choose a future or past date.

Regular & Substantive Interaction

For both federal requirements and effective teaching regular & substantive interaction (RSIs) is a crucial part to an Online course. The U.S. Department of Education requires that all Online courses for which students may use Title IV funds (federal financial aid) include regular and substantive interaction between students and instructors. In short, regular and substantive interaction (RSI) is one of the key elements distinguishing distance education from correspondence education and thus one of the central determinates for students' ability to use Title IV funds.

Five other critical factors distinguishing distance education from correspondence education are as follows:

1. Distance education should be delivered through an "appropriate" form of Online media.
2. Distance education must use instructor or instructors that meet accreditation requirements for instruction in the subject matter.
3. There should be at least two forms of substantive interaction.
4. There must be "scheduled and predictable" opportunities for instructor/student interaction.
5. Instructors must be responsive to students' requests for support (U.S. Department of Education Issues Final Rules on Distance Education and Innovation [NC-SARA, 2020])

Sample communication Plan:	
To Students - How I Will Communicate with You	
Contact time expectations	You can email me through Canvas or my Umich address at any time. Please allow for a 24-hour response time Monday – Friday.
Announcements	I will be using "Announcements" and the Canvas inbox to communicate important course information and updates. You may expect 1-4 such announcements each week. Check your Umich email regularly.
Discussion Comments	I will participate via comments and feedback on Discussion Boards during (TIMES/DAYS)
Recorded Lectures	I will post lectures on Canvas for you to watch and complete assignments based on them.
Synchronous Lecture	I will teach/lecture during our regular class time of (TIME) on (DAYS).
Attendance	I will be taking attendance; you will be expected to participate as though this class were still face to face. Your responses to live questions during lecture will be recorded using iClicker.

The above "Sample Communication Plan" is from University of Michigan's Online Teaching site. For your communications replace Umich with LCCC.

The Department of Education defines regular and substantive in distance education as "regular" being taking place on a predictable and scheduled basis and "substantive" meaning students are engaged through

teaching, learning, and assessment as well as at least two for these five activities:

1. Providing direct instruction.
2. Assess or provide feedback on a student's coursework.
3. Providing information or responding to questions about the content course or competency.
4. Facilitating a group discussion regarding the content of a course or competency.
5. Other instructional activities approved by the institution's or program's accrediting agency.



Recommendations for Promoting RSIs in Online Courses:

- Set clear expectations for interaction in the syllabus.
- Send course announcements or other messages at regular intervals throughout the quarter. Announcements that connect previous work to the upcoming week's activities.
- Brief overviews of assignments, setting them in context and explaining expectations, either live, by video, or via a detailed rubric.
- Provide timely, individualized, and in-depth feedback on student work.
- Actively facilitate Online discussions and chats.
- Conduct regularly scheduled Online review sessions, tutorials, office hours, or individual appointments.
- Interactive videos with detailed feedback (quizzes, reflection points, etc.)
- Collect feedback from students, colleagues, or support specialists.

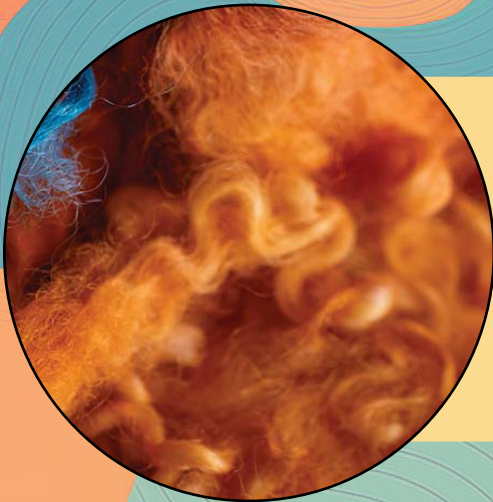
